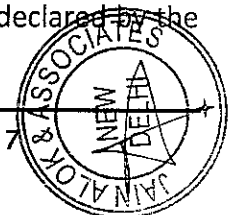

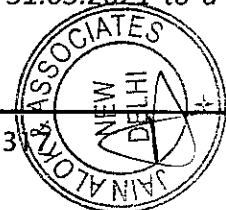

management, all such transactions were on arm length basis and were in the ordinary course of business. Therefore, Section 188 of the Act is complied with;



